TERMS OF REFERENCE & REQUEST FOR QUOTATIONS

Introduction:

It is the intention of uThukela Water (Pty) Ltd to obtain services from an Asbestos certified contractor that will be responsible for the removal and repair of the Ngagane asbestos cement raw water pipe line.

Background:

UThukela Water (Pty) Ltd Ngagane Water Treatment plant supplies bulk potable water to Newcastle, Madadeni and Osizweni Towns and surrounding areas. Some of the raw and potable water pipe network contains asbestos or asbestos related material pipe lines.

Methodology and Approach:

uThukela Water requires the services of a registered, certified Asbestos Contractor responsible for the repair, removal and disposal of the section of asbestos/ cement pipe to be repaired on the Ntshingwayo raw water pipe line.

Specifications and Scope of Work:

- Remove section of pipe with leak.
- Supply pipe section with couplings and other material required.
- Conduct repair and remove, transport and disposal of asbestos related material to a legal designated site.
- Submit documents confirming the correct disposal of material.

Returnable documents:

1. Submit Department of Labour Approval Registration as an Asbestos Contractor with the Chief Inspector. (Attach Approval Certificate)
2. Submit detailed quotation stipulating cost of material supplied, time, travelling, sundries etc.

Preference points will be awarded to service providers using their B-BBEE status level of contribution.
