MAJOR SERVICE OF HIDROSTAL IMMERSIBLE PUMP AT THE NGAGANE RIVER PUMP STATION

1. Introduction:

As a bulk water supplier, it is the intention of uThukela Water to request quotations from suitable suppliers for the Major servicing of the Hidrostal Immersible pump at the Ngagane river pump station.

2. Background:

The Ngagane River Pump Station is situated approximately 10km's from Newcastle. Raw water is pumped from this pump station to the Ngagane Water Purification Plant. Raw water is then purified at the Plant.

3. Requirements:

To carry out a Major service on the Hidrostal Immersible pump situated at the Ngagane river pump station.

Supply and delivery:

Strip Hidrostal Immersible pump, inspect and measure all components, test motor stator core and windings
Replace upper and lower bearings
Replace upper and lower mechanical seals
Replace o-rings, reset disc springs and lock ring
Assemble pump and motor
Replace cooling liquid
Pressure test pump
Install pump and commission

Quotation is to include: All spares, labour, materials, consumables and transportation
