TERMS OF REFERENCE & REQUEST FOR QUOTATIONS

PROCUREMENT OF UPVC PIPES AND VJ COUPLINGS FOR THE STERKSTROOM PIPELINE

1. Introduction:

As a bulk water supplier, it is the intention of UThukela Water to request quotations from suitable suppliers for the supply and delivery of UPVC pipes and VJ Couplings.

2. Background:

The Sterkstroom pipeline is a raw water pipeline that supplies water to the Biggarsberg Water Purification Plant. The Biggarsberg WPP is situated approximately 5km's from Dundee. As the water service provider uThukela Water is responsible for the maintaining of the Water Plant, raw water pipelines, potable water pipelines and infrastructure within its designated area.

3. Requirements:

The supply and delivery of 250mm UPVC Pipes and Thomson VJ Ranger Couplings which are to be delivered to the Biggarsberg Water Purification Plant.

DESCRIPTION:
1. UPVC Pipe, 250mm, Class 16, 6m length. Pipe ends/joints: Spigot and socket pipe with integral socket and locked-in rubber ring seal. Quantity: twenty (20) lengths.
2. Thomson VJ Ranger Coupling, 250mm x 267mm, centre socket 300mm wide long collar. Quantity: 10 off
Notes: - Quotations are to include: The supply and delivery to the Biggarsberg Water Purification Plant approximately 5 km's from Dundee.
