Assists the Plant Process Controller in controlling and operating the purification plant equipment and processes to purify and clarify water for human consumption and effluent discharge; operate valves to regulate flow; replenishment of all stock; perform filter backwash according to schedule and as per backwash procedure; operate the clarifiers/sedimentation tanks by withdrawing sludge to control the overflow water turbidity; cleaning of flocculation channels/filter beds/tile basins/launders/screens/clarifiers/sedimentation tanks/polymer mixing tanks/chlorine systems and bio filters; operations of sludge dams/sludge drying beds; monitor sludge dam level and control sludge dam overflow water; monitors plant and equipment for any deviation; malfunction or pump tripping and take immediate action if there is an unsafe condition and report immediately to Senior for action; monitors process units to ensure proper functioning and meet set standards; operate in a Hazardous Installation Site; take process samples, record meter readings; cleans and tidies plant; pump station; office building; backwash system and all plant and equipment; assist in offloading and storage of treatment chemicals.
